# **VTR AND TSOA MERGE!**

When TR-7 and TR-8 production ended in 1981, and with the Triumph Acclaim only available in European markets, most enthusiasts familiar with the Triumph Sports Owners Association (TSOA) assumed it would only be a matter of time before that organization came to an end. TSOA was totally supported by Jaguar-Rover-Triumph (JRT) in Leonia and John Dugdale, Editor of the TSOA Newsletter, was until his recent retirement, a full-time employee of JRT. The token \$3 TSOA subscription charge certainly did not reflect the total cost of a TSOA subscription. The additional funds, therefore, were supplied by JRT's Public Relations department.

With Triumphs no longer being sold in the USA, the value of TSOA news as an advertising and marketing tool was gone and it no longer was good business practice to continue subsidizing the TSOA Newsletter. TSOA members should not feel slighted by this since the same thing occurred over a year ago when the MG Magazine lost its JRT support after MG production stopped.

What has all of this led to? Since JRT did not want to leave its TSOA members 'out in the cold', they asked VTR if we

would like to continue the TSOA responsibility of providing the direct channel of communication between the enthusiast and the factory. At that time, it had already become obvious to VTR that the word Vintage in our name did not reflect what VTR consisted of since local memberships and turnouts at National events reflected the total range of Triumph models. Recognition of that fact led to the elimination of the 10 year rule, as reported elsewhere in this newsletter, and allowed VTR to take the necessary steps to accept the responsibility it was being asked to undertake.

The first step has been the identification of The English Channel as now incorporating the TSOA Newsletter and mailing complimentary copies of this issue to each of the 1200 TSOA members. So if you're a TSOA member reading our newsletter for the first time, we welcome you to VTR and hope you will join the Vintage Triumph Register so you can continue receiving this newsletter and The Vintage Triumph magazine.

We are proud of the fact that JRT has selected VTR to carry on the responsibilities and traditions of TSOA and we look forward to fulfilling those obligations.

# **TECH TIP**

On some newer domestic automobiles, propane (as used with Benzomatic torches, etc.) is used to make idle air/fuel ratio settings. The propane equipment (bottle, valve and hose) can also be used to discover vacuum leaks. If you have a rough idling engine, turn on the propane valve and move the hose along the intake manifold flanges, carburetor flanges and other areas with vacuum leakage potential. If the engine idle smooths out, you've found the vacuum leak.

**CAUTION:** Propane is flammable! Use it sparingly in an open area and put out that cigarette first!

# VTR RECOGNIZES ALL TRIUMPH MODELS

You may not have noticed it, but back in the July-Aug. 1981 issue of The English Channel, buried in the May 26th VTR Board Minutes, it was reported that the board agreed to recognize all Triumph models. Prior to that decision, VTR had a 10 year old cut-off that was applied to material published in The Vintage Triumph magazine. Obviously, this change has an even greater significance now that we are welcoming former TSOA members into VTR, who for the most part own newer Triumphs.

Featuring the TR-7 photo on issue 29 of the magazine was probably the first major departure from the old 10 year rule. In addition, an upcoming issue (#33, Second quarter 1982) will be devoted to the TR-6. As the only Triumph organization in the United States now open to all Triumph owners and enthusiasts, VTR looks forward to meeting the needs and interests of all its members from owners of pre-war Triumphs thru TR-8 (and Acclaim owners if someone can sneak one into the USA).
